You can write in the name of an Association Member or assign the Proxy to the Board of Directors. The signed and dated Proxy, valid only for this Annual Meeting, must be received at the Clubhouse before the start of the Annual Meeting on September 21.

At the Annual Meeting, the Board President, Jan Bedard, will give the State of the Association address and the Treasurer, Michael Mazza, will provide a summary of the Association's proposed 2023 Budget.

PROPOSED 2023 BUDGET

The detailed proposed 2023 Budget is available in the Clubhouse and on the website.

This Budget proposes a \$5.00 increase to the current \$91.00 per month assessment for fiscal 2023 and sets aside \$91,525.00 for Reserves.

The Proposed 2023 Budget will be voted on at the <u>6:30</u> <u>pm. Board Meeting</u> in the Party Room, prior to the Annual Homeowners' Meeting, on Wednesday, Sept. 21, 2022 at 7:00 pm.


